The mission of United Way of Benton & Franklin Counties is to improve lives and strengthen communities. We build collaborations with individuals, businesses, and nonprofits to address challenges that no one agency can solve alone to provide the building blocks of opportunity - education, income, and health - that every person needs to thrive. Together, we're solving our region's biggest problems and creating lasting change.

Donor Choice Program - In 2020, 356 Non-Profit Organizations received designated contributions through United Way's Donor Choice Program. Before distributing designated gifts, United Way screens each organization to verify compliance with Section 501(c)(3) of the Internal Revenue Code and USA Patriot Act.

4b (Code:) (Expenses \$ 877,533 including grants of \$ 766,692) (Revenue \$ 0)

Community Impact Funding - United Way provides grants to local non-profit organizations to address our community's areas of greatest need. In 2020, United Way provided grants to support 55 programs to improve the health, education, and financial stability of thousands of people in our community by partnering with 25 local non-profits. In addition, United Way awarded 104 rapid response grants to address challenges created by the COVID-19 pandemic. Our organization obtained a grant to provide nearly \$17,000 in gift cards to support the basic needs of students at Columbia Basin College and WSU Tri-Cities. Our local United Way also facilitated the placement of nearly \$405,000 in FEMA Emergency Food and Shelter funds with 13 local nonprofits. When the pandemic required closure of our non-profit training center, our organization converted the space into a PPE distribution depot and facilitated the ordering, inventorying, and distribution of 264,675 face masks and nearly 60,000 pieces of additional PPE to more than 50 local nonprofits. This helped these organizations save money and safely serve clients.

2020 Census Education - In November 2019, United Way entered into a contract with the State of Washington to educate Washington State residents about the 2020 Census, mobilize "trusted messengers" within communities to build confidence and support broad participation in the census. We also provided support to maximize self-response to the 2020 Census and support cooperation in the Non-Response Follow-Up effort that was extended due to the pandemic. The period of performance ended September 30, 2020.


